SUBJ.: ARREST OF FORMER SCOUTMASTER FOR SEXUAL ABUSE

I have just been notified by telephone by the police department of the arrest of a former Scout leader on charges of sexual abuse.

According to police, an adult identified as Samuel Fried of Queens, who says he was a Scout leader with a troop attached to St. Demetrius Church in that borough, was arrested December 30 and charged with sexual abuse of a minor. Police say the charge was brought by the mother of a Scout in Fried's unit.

This information was given to me at approximately 2:30 p.m. today by Detective Joseph Gelfand, who is assigned to the "Sexual Exploitation of Children" Task Force, a joint venture of the New York City Police Department and the Federal Bureau of Investigation. His office is at [REDACTED] here in Manhattan; his telephone is [REDACTED].

I have notified Dennis St. Jean of the above. Dennis confirms that the adult in question was let go from unit duties during the summer.


Dear Sam:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America.

You should understand that Boy Scouts of America membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the Boy Scouts of America seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a Boy Scouts of America member should be granted or reinstated. The procedures for review are attached.

SUBJECT: SAMUEL L. FRIED, CONFIDENTIAL FILE LISTING



The legal case against Samuel L. Fried involving the sexual child abuse of a Scout is still open and may be for sometime. The parents of the Scout involved refused to allow their son to testify in court.

In order to assist you in closing this file, I contacted the investigating agency, the F.B.I./N.Y.P.D. task force on the sexual exploitation of children, as well as the Queens Assistant District Attorney, Alice Vachss, who is prosecuting the case. In both "off the record" conversations, the parties insisted that Mr. Fried not only committed the criminal acts he is charged with, but additionally, committed similar acts with other Scouts. They have determined this during the course of their professional investigation.

Based upon these findings, I am requesting that Samuel L. Fried's registration suspension be sustained and that he not be permitted to re-register in Scouting. This decision will stand regardless of the final outcome of legal action. As previously requested, I have enclosed a photocopy of his signature for future identification purposes.

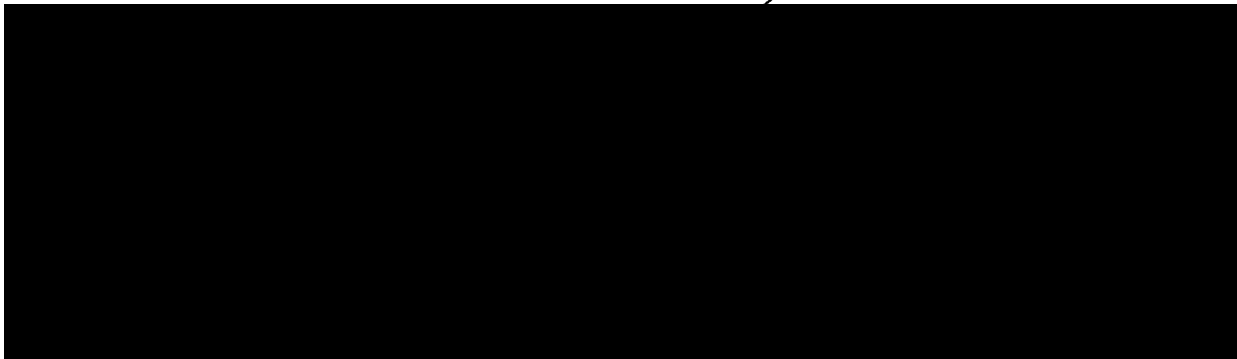

The FBI advised Robert Williams, PR Director, Greater NY Councils on Monday January 4 of the arrest on December 30, 1987 of Samuel Fried, a volunteer in the Greater New York Councils, on a charge of sexual abuse of a minor brought by the mother of a Queens Boy Scout.
