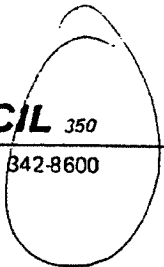

This is regarding Robert Jacoby, registered as Assistant Scoutmaster in Troop 205 sponsored by the Eugene Field School P.T.A., Teaneck, N.J.

I have just been informed by the Teaneck Police Department that within the next 30 days Mr. Jacoby will be charged with at least nine (9) charges of child molesting. Mr. Jacoby has verbally resigned to the Scoutmaster, John Miller, in the presence of the Committee Chairman, Gordon Pekey.

As soon as Jacoby is officially charged, the Teaneck Police Department will make the case against him available to us. I am told, by the Police Department, that Jacoby has already admitted to most charges against him. After he is officially charged, I will submit the necessary evidence and the Confidential Record Sheet to National Registration Service.

I hope that at this time National can officially drop Robert Jacoby from Troop 205, Teaneck, N.J.
