If any additional information is made available to you we would appreciate your forwarding it to us.

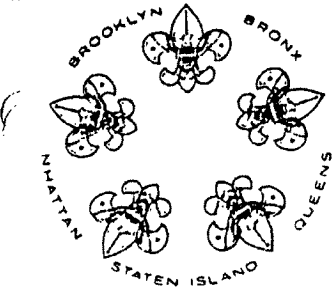

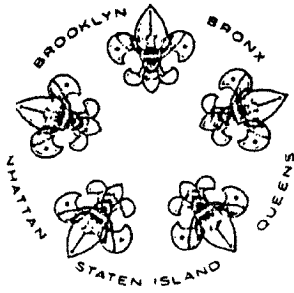

Robert Methvin, Associate Advisor Post 948, Eastern District, Brooklyn formerly with Explorer Post 88, Borough Queens.

The above was alleged to have committed an immoral act of fellatio on a member of Post 948. With the above information regarding the immoral act, Robert Methvin was confronted by the District Executive, Jim Foy, District Commissioner, Joe Pugliesi and the Explorer Advisor, Anthony Crisci. Upon hearing the allegations against him, Robert Methvin admitted the aforesaid act was committed by him with the boy, his reaction indicated he expected the confrontation.

Robert Methvin, at this time, was asked for his membership card, and resigned from Scouting and indicated that he would never again approach Scouting or its related activities in any capacity at any time and under any circumstances.

Robert Methvin is approximately 6' 0" tall, 235 pounds, 40 years of age, hair brown and balding. He has a speech impediment, epilepsy.

He indicated he was a Captain in the Air Force, discharged. (status unknown.)
