Through the help of the guidance counsellor of the Marion Central High School it was learned that Mr. Eugene Miller had homosexual tendencies. This suspicion was heightened when Eugene continued running around with a high school boy. The subject was married but had been separated for 2 years and according to the guidance teacher homosexuality was probably at the base of the separation. (This was later confirmed as true) Because the subject began to run around with another high school boy as well, the guidance teacher felt it wise to call in the B.C.I. on the case. It so happened that the next week one of the boys that had been close to the subject was caught on a traffic charge by the State Police. This boy was held on the charge since it was known that he was also linked with the subject. When confronted with the charge that the subject had been having homosexual relations with the youth he confessed. The subject was then picked up by the B.C.I. and held on the charge homosexuality at the County Jail at Lyons, N.Y. for approx. 4 days. He is now out on \$1,000 bail pending trial in the Fall.
