Purpose & Background

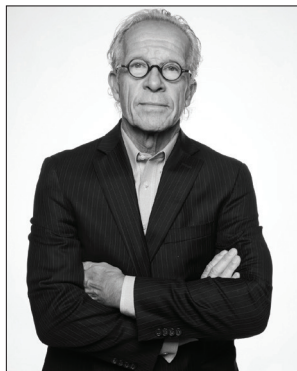
This report contains the names of clergy associated with the Diocese of Buffalo who have been accused of committing sexual offenses against minors. The vast majority of the claims against these individuals have not been evaluated in a civil court. Accordingly, the allegations should be considered just allegations and should not be considered proved or substantiated in a court of law. All individuals should be considered innocent until proven guilty. In many situations, the statute of limitations has expired preventing the cases from being heard in a court of law.

On March 13, 2018, Jeff Anderson & Associates released the identities and assignment histories of 13 clerics with public allegations of sexual misconduct and called upon the Diocese of Buffalo to disclose the identities of the other clerics with credible allegations of sexual misconduct. As a result the Diocese provided a list of 42 clerics on March 20, 2018. However, the Diocese of Buffalo refused to provide the full context, whereabouts and histories of these accused clerics.

This report is an attempt to compile information already available to the public from various sources in the public media; bishopaccountability.org; and other sources that have attempted to chronicle this information for public use. This report is intended to raise awareness about the important issue of clerical sexual abuse, provide the public with vital information including assignment histories, and provide awareness of the Independent Reconciliation and Compensation Program available to survivors. Assignment histories are approximations and were compiled from the Official Catholic Directory, bishopaccountability.org and media reports.

Jeff Anderson & Associates, P.A.

Jeff Anderson & Associates, P.A. pioneered the use of civil litigation to seek justice for survivors of childhood sexual abuse. Through its work, Jeff Anderson & Associates, P.A. seeks to bring hope, healing, accountability and justice to survivors of child sexual abuse. The attorneys have advocated for survivor rights in New York for many decades, having filed their first lawsuit in New York on behalf of a child sex abuse survivor in approximately 1988. In addition to seeking legal accountability, the firm has supported survivors of abuse by bringing public awareness to the cause and even testified before the state legislature endorsing reforms to the statute of limitations. Recently, Attorney Mike Reck filed the first case alleging that a Catholic Diocese in New York was committing a public nuisance by refusing to disclose the identity and history of its sexually abusive priests.

The Independent Reconciliation and Compensation Program (“IRCP”)

The Diocese of Buffalo has announced the creation of the Independent Reconciliation and Compensation Program (“IRCP”). Similar programs are already in existence in the Archdiocese of New York; Diocese of Brooklyn; and the Diocese of Rockville Centre. The IRCP is a third party administered fund that will compensate some survivors of childhood sexual abuse by priests. Survivors can keep their identity fully confidential. Currently, the IRCP is available only for survivors who previously reported their abuse. It is possible the program will be made available in the future to survivors of abuse who have not yet reported their abuse.

While the IRCP does provide some measure of justice and accountability, it is also complex and requires a survivor to waive his/her future rights if a settlement is received. A survivor participating in the IRCP can enroll in the program alone or may wish to retain an attorney to assist them. An attorney can communicate directly with the IRCP and the Diocese to shield the survivor from further trauma.

A deadline of June 1, 2018 exists for those who qualify for the IRCP in the Diocese of Buffalo.

Publicly available information and documents demonstrate a long history of child sex abuse in the Catholic Church and patterns of cover-up and institutional negligence by dioceses. We must act now so that the past does not become a prologue to the future. As survivors are empowered to speak up and hold the Diocese of Buffalo accountable, we expect more information will be forthcoming about the true nature and pervasiveness of child sex abuse in the Diocese of Buffalo.

History of Clerical Sex Abuse in the Diocese of Buffalo

Clerical sexual abuse of children has a long history in the Catholic Church. Of the 53 clerics accused of child sex abuse in the Diocese of Buffalo since 1950, only two, Fr. Fred Ingalls and Fr. Gerald Jasinski, have faced criminal prosecution. This is due in part to the failure of the leadership of the Diocese to report allegations of abuse to law enforcement and a lack of transparency regarding the prevalence and risk of sexual abuse by priests.

Former Chancellor and Vicar General of the Diocese of Buffalo and current Bishop of Syracuse, Robert Cunningham handled allegations of child sex abuse in the Diocese from 1974 to 2004. Bishop Cunningham's depth of knowledge regarding child sexual abuse in the Diocese is recounted in a 2004 letter. He states that allegations were made against 53 members of the clergy in the Diocese of Buffalo and that the Diocese had paid \$670,000 to survivors of sexual abuse.

Publicly available information and documents demonstrate a history of moving offending clerics to avoid accountability and criminal prosecution when abuse of children becomes known to Diocesan leadership. This approach includes the relocation of offending clerics to different parishes, missions, dioceses and treatment facilities.

The Use of Treatment Centers

Dioceses across the United States have used treatment centers for priests accused of child sex abuse. These centers include, but are not limited to, the House of Affirmation, Saint Luke Institute, Servants of the Paraclete and Saint John Vianney Center. The closest such facility to the Diocese of Buffalo is the Southdown Institute in Aurora, Ontario, run by the Canadian Conference of Catholic Bishops.

At treatment centers, Catholic clerics have diagnosed, treated and discharged priests since the mid-20th century. In 1947, under the direction of Fr. Gerald Fitzgerald, the Archdioceses of Boston and Santa Fe opened the Servants of the Paraclete treatment center. The same year, the Archdiocese of Philadelphia started the Saint John Vianney Center in Downingtown, Pennsylvania. In 1980, the United States Conference of Catholic Bishops opened the Saint Luke Institute in Silver Spring, Maryland. All of these facilities function as treatment centers for offending priests.

Handling of Child Sex Abuse Allegations

The Code of Canon Law, which governs the conduct of Dioceses and Bishops, dictates the procedures to be adopted in response to allegations of child sex abuse. Since 1922, the Code of Canon Law has recognized the heinous crime of sex abuse of prepubescent children. Canon Law requires that bishops carry out a preliminary investigation of allegations of sexual abuse and inform the Congregation for the Doctrine of the Faith for further action. Documents regarding the allegation of sex abuse are sent to the Papal Nuncio Office in Washington, D.C. and a copy is retained by the Diocese.

Canon Law also requires local dioceses to maintain all documents pertaining to diocesan business in their archives. This depository of information if disclosed would demonstrate the extent of the problem of clerical sex abuse.

The following names are priests connected to the Diocese of Buffalo accused of committing sexual offenses against minors.

Fr. John R. Aurelio



Ordination: 1966

Notes: Fr. John R. Aurelio was suspended in 2003 after admitting to sexually abusing multiple children with Fr. Bernard M. Mach. Fr. Aurelio is believed to have ceased functioning as a priest and moved to Venice, Florida after being suspended from ministry. On March 20, 2018, the Diocese of Buffalo included Fr. Aurelio on its list of priests who have been accused of child sexual abuse. The diocese did not disclose any information regarding the allegations or Fr. Aurelio's prior assignments. According to the diocese, Fr. Aurelio died in 2009.

Fr. Donald W. Becker



Ordination: 1967

Notes: Fr. Donald W. Becker was placed on medical leave in 2002 in the wake of allegations of child sexual abuse. In 2018, one man alleged that Fr. Becker sexually abused him as a child at St. Bonaventure and two other men alleged that Fr. Becker sexually abused them as children at Saints Peter and Paul. After the first three men came forward, several other men reportedly accused Fr. Becker of sexually abusing them as children. Fr. Becker has denied all allegations of child sexual abuse. On March 20, 2018, the Diocese of Buffalo included Fr. Becker on its list of priests who have been accused of child sexual abuse. The diocese did not disclose any information regarding the allegations, Fr. Becker's prior assignments, or his current location. As of 2016, Fr. Becker was believed to be a retired priest residing in Fort Myers, Florida.
